- A. Faculty Senate Antiracism Task Forces: Recommendations. Task Force Co-Chairs, Senate Exec. (Action). The recommendations from the four task forces will be considered for endorsement. While the Faculty Senate heard the task forces' presentations and recommendations at the May 4 meeting, action on the items was continued until this meeting.

- C. Attendance Policy and Active Duty Service Member Students, Jane Killer (Action). Veterans' Resource Center faculty member Killer will inform the Senate of recent legislative changes and mandates by the Department of

Veterans Affairs requiring institutions of higher learning to "Allow for [students] to be gone for both long and short periods of time due to service obligations." The VRC faculty would like Faculty Senate to recommend that faculty honor this new law and work with active duty students to award Incompletes and to direct Senate Exec to work with administration to implement the new policy.
