**PROPOSED REVISION to Faculty Senate Bylaws –
ARTICLE IV Action on Agenda Items:**

1. When an item appears on the Senate Agenda (whether as an action item or an information item) for the forthcoming Senate meeting in the manner prescribed in Article III above, the initial discussion on that item takes place at that meeting and is eligible to be acted upon at that meeting unless referred to committee or a member of the Senate requests that it be postponed until the next meeting of the Senate. **A vote of 2/3 of the Senate will allow the item to be acted on after the initial discussion without postponement.**

2. When an item is introduced from the floor at a meeting of the Senate (in keeping with Brown Act guidelines), if appropriate for and warranting Senate consideration or action, it will be eligible to be acted upon at that meeting unless a member of the Senate requests that it be postponed until the next meeting of the Senate. **A vote of 2/3 of the Senate will allow the item to be acted on after the initial discussion without postponement.**
