Scott Lewis, J.D., Managing Partner for TNG Consulting, has worked with members of the District Safety Committee to propose revisions to Administrative Procedure 7600, along with one minor proposed change to Board Policy 7600.

The proposed changes to this board policy and administrative procedure will ensure that Campus Safety offices continue to operate in a consistent manner, according to industry standards, and provide appropriate training for officers to continue offering excellent services at all three campuses."
